Specificity	The antibody MEM-136 recognizes a common extracellular epitope on beta-chain of human HLA-DR and HLA-DP. It reacts with alpha/beta dimer as well as with dissociated beta-subunit. DR and DP are the isotypes of human MHC Class II molecules expressed on antigen-presenting cells (APC; dendritic cells, B lymphocytes, monocytes, macrophages).
Immunogen	PHA-activated peripheral blood lymphocytes.

Preparation	Purified antibody is conjugated with Pacific Blue™ NHS ester under optimum conditions and unconjugated antibody and free fluorochrome are removed by size-exclusion chromatography.
Formulation	Stabilizing phosphate buffered saline (PBS), pH 7.4, 15 mM sodium azide
Storage and handling	Store at 2-8°C. Protect from prolonged exposure to light. Do not freeze.
